

Aldham Olde Tyme Rally – 2026

Terms and Conditions of Entry

1. Exhibits

- 1.0 All exhibits must be pre-entered. **Entry on the day is not permitted.**
 - 1.1 Exhibits should normally be at least 25 years old and are accepted at the discretion of section organisers.
 - 1.2 Other exhibits of exceptional interest may be considered.
 - 1.3 Space limitations may restrict the number of exhibits accepted in some sections.
 - 1.4 Exhibits shall be on site and set up by 10:00am (public opening time) and remain on display until 4.30pm
 - 1.5 Exhibitors must ensure their display is presented safely and does not create any hazard to members of the public (e.g. sharp edges, hot surfaces, and trip hazards must be suitably guarded).

2. Insurance

- 2.0 All working exhibits shall be covered by Public Liability Insurance for **not less than £2 million.**
 - 2.1 A copy of the insurance policy must be provided when requested by the organisers.
 - 2.2 Insurance certificates must be readily available for organisers to check on arrival or during the event.
 - 2.3 **Steam-powered exhibits:** A valid boiler certificate and 10-year hydraulic test certificate must be provided on request (NTET disc preferred). Exhibitors unable to provide proof will not be permitted to operate the boiler.

3. Steam & Traction Engines

- 3.0 Exhibitors must comply with all relevant safety guidance and operate only under the direction of event marshals.
 - 3.1 Operation of steam engines must cease if requested by organisers or safety officials.
 - 3.2 Steam exhibits and associated equipment must be set up to prevent unauthorised public access to hot or moving parts.
 - 3.3 Fuel and other flammable substances must be stored securely away from public access.

4. Vehicles

- 4.0 A **5mph speed limit** applies throughout the site at all times.
- 4.1 Vehicles may only move into the designated display areas under the instruction of a marshal.
- 4.2 Outside of display times, vehicles must be parked in designated areas, movement is permitted around the site with permission from a section organiser.
- 4.3 Vehicles must arrive by 10:00am and may not leave before 4:30pm (unless agreed with the event organiser).
- 4.4 The Road Traffic Act applies to vehicles driven to and from the event.
- 4.5 Drivers must have a valid driving licence for the vehicle they are driving.
- 4.6 Drivers must have valid vehicle insurance as per clause 2.1 / 2.2
- 4.7 Carriage of passengers on tractors is prohibited unless the vehicle is specifically designed to do so.
- 4.8 Vehicles must have a valid MOT certificate where legally required.

4.9 Steam-powered exhibits are not permitted to be driven by anyone under the age of 18. Operation is restricted to competent persons only.

4.10 Engines must remain switched off while on display unless authorised by a marshal for a supervised manoeuvre or demonstration.

4.11 Refuelling is not permitted during public opening hours or in areas accessible to the public.

4.12 Exhibitors must ensure suitable guarding is used if any moving components are exposed during demonstrations.

4.13 Movement may be restricted due to weather or ground conditions. Exhibitors must follow marshal instructions immediately.

4.14 Exhibitors may, at their discretion, allow members of the public to sit in or view the interior of the vehicle. Under no circumstances may any visitor operate controls, start engines, or touch any component that could cause movement or present a hazard.

4.15 Exhibitors are encouraged to supervise any public access closely and may refuse access at any time if they consider it unsafe or inappropriate.

5. Smoking

5.0 Smoking is not permitted in marquees, toilets, or enclosed areas.

6. Dogs

6.0 Dogs must be kept on a lead. Owners are responsible for any fouling.

7. Camping

7.0 Exhibitors must indicate on the booking form if staying Friday and/or Saturday night.

7.1 Camping is permitted only in designated areas once a caravan or tent has been accepted as part of the exhibit entry.

7.2 Noise must be kept to a minimum between 23:00 and 07:00. Please be courteous to fellow exhibitors when using generators.

7.3 Generators must be positioned and/or fenced to prevent public access and reduce noise exposure.

8. Auction

8.0 Vendors intending to sell items at the Saturday auction must complete a Lot Log prior to booking in items. A copy will be issued with passes.

8.1 Payout is by bank transfer.

9. Selling

9.0 The sale of multiple items from beside exhibits is prohibited.

10. Behaviour & Conduct

10.0 Exhibitors must not operate or demonstrate vehicles or machinery whilst under the influence of alcohol or drugs.

10.1 All instructions given by event marshals, safety officials, or emergency services must be followed immediately.

10.2 In any emergency, engines must be shut down without delay and visitors given priority for safe evacuation.

11. GDPR & Data Protection

11.0 Personal data (name, address, telephone number, vehicle information) will be used solely for event administration and safety purposes.

11.1 Data will be stored securely and not distributed to any third parties.

11.2 By signing or submitting the entry form, exhibitors consent to the use of their data as above.
